Sub: Follow up for our attached letter for request for re-start of exhibitions during Unlock Phase 3.0. Ref: Our Letter No. IEIA/1015/2020 Dt.17<sup>th</sup> July 2020

This has reference to our earlier letter dated 17<sup>th</sup> July 2020 regarding our request for announcing re-start of exhibitions during Unlock Phase 3.0 across the country.

May we reiterate that Exhibitions are Organised business activities and countries across the globe including UK, Germany, Italy, Malaysia, Hong Kong, Spain, China, Thailand, Poland, South Korea, Australia, New Zealand Taiwan and many other leading economies have announced and allowed re-start of exhibitions owing to the organised eco-system and the economic value brought in by these towards boosting the trade and commerce. Moreover, Exhibitions are the catalytic sectors that boost the Domestic Economies and can support Govt.'s vision of an "Atmanirbhar Bharat"

The ongoing uncertainty around the re-start of exhibitions and the standstill brought in by COVID 19 has already impacted many livelihoods with mass lay-offs and no work available to the huge base of permanent and contractual workforce.

As exhibitions require at least 6 to 8 weeks of advance planning, it is of high urgency that the sector be supported for immediate revival by announcing of an earliest re-start date please.

It is to be noted that the <u>re-opening of malls during Unlock Phase 2.0 in India, further strengthens the</u> <u>case for re-opening of Indoor exhibitions.</u> Exhibitions enable 'organized gathering' of exhibitors and business visitors to facilitate trade and business, as opposed to 'mass gatherings'. Business and industrial exhibitions are structured in terms of process and movement of people from start to end, and are designed to create a market place for business. The human density inside an exhibition is not higher than that of a mall which are already permitted to be opened as part of Unlock 2.0. Hence, Business to Business exhibitions can easily be conducted with strict adherence to the SOPs to ensure the safety protocols.
